We posted an electronic Fall 2017 newsletter on Dec. 26, 2017. It contained election results, a list of POMSIGMAA and philosophyrelated events at JMM 2018, and a brief article encouraging members to participate in our listserv discussions. Over the year, we had more listserv activity than usual, with a lengthy debate on numbers as physical objects (21 posts), realism versus nominalism (11 posts), the philosophy in math in theology (10) and suggested examples of mathematical beauty (27 posts).
